**RULES PERTAINING TO THE ISSUANCE AND USE OF SEASON PASS – PLEASE READ AND SIGN:**

- 1) Applications are made with the explicit assumption of risk by the individual, or individuals requesting same and applicant acknowledges that skiing is subject to contract printed on the pass which releases Alpine Valley for injury to personal property.
- 2) For purpose of eligibility, a "family" is defined as the head of household, plus his or her spouse and all dependent children who will not be 18 years of age by January 1, 2012. A dependent child is one you are presently claiming as a deduction on your federal income tax. Proof of family relationship may be required.
- 3) Passes must be worn properly attached to outer garment between waist and neck, and not on hats, gloves or goggles.
- 4) Lost or stolen passes must be reported immediately. Lost passes will be replaced for a \$5.00 charge.

- 5) Season passes are not transferable and no refunds will be made under any circumstances. Any misuse of a pass shall cause forfeiture of all skiing privileges for the remainder of the season. Misuse may constitute theft of services which is punishable under Ohio criminal law.
- 6) A season pass may be revoked on the spot, without refund, for abuse of skiing/snowboarding privileges or violation of rules. Foul language, dangerous skiing, property damage, threatening behavior, or smoking under the age of 18 are cause for immediate revocation of the pass without refund. Management reserves the right and has the obligation to enforce the rules of the slopes, as well as the OHIO SAFETY IN SKIING LAW (ORC 4169).
- 7) Season passes are for lift passes only and do not include lessons or rental equipment. Alpine Valley will make all efforts to maximize the number of days in the ski season but cannot and does not promise a fixed number of skiing days, either expressed or implied. This ski pass expires at the end of skiing for this season.

SKIER/SNOWBOARDER RESPONSIBILITY CODE:

- 1) Ski/Snowboard under control at all times and in such a manner that you can stop or avoid other skiers or objects.
- 2) When skiing downhill or overtaking another skier, you must avoid the skier below you.
- 3) You must not stop where you obstruct a trail or are not visible from above.
- 4) When entering a trail or starting downhill, yield to other skiers.
- 5) All skiers shall wear retention straps or other devices to prevent runaway skis and snowboards.
- 6) You shall keep off all closed trails and posted areas and observe all posted signs.
- 7) Prior to using any lift, you must have knowledge and ability to load, ride and unload the lift safely.

I understand and accept the fact that skiing in its various forms is a hazardous sport, and that bare spots, variations in snow, ice and terrain along with bumps, moguls, stumps, forest growth and debris and rocks and many other hazards or obstacles exist within this ski area. In using the ticket/pass and skiing at this area, such dangers are recognized and accepted and injuries may result, and therefore assumes the burden of skiing under control at all times. I agree, as a condition of being allowed to use the ski area facility and premises, that I freely accept and voluntarily assume all risks of personal injury of death or property damage, and release Alpine Valley ski area, and its agents, employees, directors, officers, and shareholders from any and all liability for personal injury or property damage which results in any way from negligence, conditions on or about the premises and facilities, the operation of the ski area including, but not limited to, grooming, snowmaking, ski lift operations, actions or omissions of employees or agents of the area, or my participation in such damage or injury of any kind which may result. The management is not responsible for ticket/pass if lost and this ticket/pass may be revoked without refund at any time by the management for misconduct or nuisance caused by the holder.
