IMPORTANT: PLEASE READ AND SIGN BELOW

In participating in the "Select Pass" program and utilizing the facilities I am aware that falls and collisions are common in skiing; that skiers can be careless and negligent, that there are dangers involved because of marked and unmarked hazards and obstructions, bare spots, ice, changing snow, bumps, stumps, stones, trees fences, towers, snowmaking machines and hydrants, and maintenance vehicles; that Ohio law requires SKIING UNDER CONTROL and learning how before riding or using lifts or tows. I hereby agree to ASSUME THE RISK of injury, including death, and in return for using these facilities, I hereby expressly agree (a) NOT TO SUE Alpine Valley, or its employees, officers, directors, agents or owners REGARDLESS OF ANY NEGLIGENCE WHICH MAY occur, and (b) that if I sue and lose, I hereby agree to pay Alpine Valley legal fees and costs.

I understand and am aware that skiing is a HAZARDOUS activity. I understand that the sport of skiing and the use of ski equipment involves a risk of injury to any and all parts of this participant's body. I also understand that the use of ski lifts and the performance of any exercises and/or maneuvers as recommended by ski school instructors also involve the same risk of injury. I hereby agree to freely and expressly assume and accept any and all risks of injury to this participant in the ski school class or lesson.

I agree that I will release Alpine Valley Ski School and Alpine Valley Ski Area, their employees, officers, directors, instructors, agents and owners from any and all negligence, responsibility or liability for injuries or damages sustained by this participant while skiing and/or participating in ski school classes or lessons. I agree NOT to make a claim against or sue for injuries or damages relating to skiing, the use of ski equipment and/or participation in ski school classes or lessons.

RENTAL SKI EQUIPMENT CONTRACT

I will be responsible for the replacement, at full retail value, of the equipment furnished under this agreement that is not returned. I agree to reimburse and hold harmless Alpine Valley for any loss or damage of any kind, other than reasonable

wear and tear, which results from the use of this equipment. I agree to return all rental equipment by the designated time to avoid any additional charges. I have made no misrepresentations to Alpine Valley in regard to my height, weight, age, or skiing ability. I agree to make certain I understand all instructions on the use of my rental equipment before using said equipment.

I understand and am aware that skiing is a HAZARDOUS activity. I understand that the sport of skiing and the use of ski rental equipment involves a risk of injury to any and all parts of this user's body. I hereby agree to freely and expressly assume and accept any and all risks of injury to the user or rental equipment while skiing.

I understand that the ski equipment to be used forms a part of or all of a ski-boot-binding system which will NOT RELEASE at all times or under all circumstances and that it is not possible to predict every situation in which it will not release, and that its use cannot guarantee this user's safety or freedom from injury while skiing. I further agree and understand that the ski-boot-binding system may reduce but DOES NOT ELIMINATE THE RISK of injuries to the lower portion of this user's leg. However, I agree and understand that the ski-boot-binding system may NOT reduce the risk of injuries to this user's knees or any other part of this user's body.

I agree that I will release Alpine Valley Ski Area, its employees, officers, directors, instructors, agents and owners, from any and all negligence, responsibility or liability for injuries or damages to the user of the equipment listed on this form, or to any other person.

I agree NOT to make a claim against or sue Alpine Valley, its employees, officers, directors, instructors, agents or owners for injuries or damages relating to skiing and/or the use of rental ski equipment issued.

I hereby agree to accept the terms and conditions of this contract. This document constitutes the final and entire agreement between Alpine Valley and the undersigned. Alpine Valley, itself, provides NO WARRANTIES, expressed or implied, and the equipment to be provided is accepted "as is."

I have carefully read this agreement and release of liability and fully understand its contents. I am aware that this is a release of liability and a contract between Alpine Valley, and myself and I sign it of my own free will.
